#### WHO CAN ENTER

The Contest is open to Canadian residents except in Quebec who are of legal age in their province/territory of residence at the time of entry.

# **HOW TO ENTER**

No purchase or payment of any kind is necessary to enter or win. The provision of a valid Facebook and/or Instagram account is required to participate in the Contest.

To enter, post a before and after photo of a home project you have done on Facebook OR Instagram listing the Paint Shop products you used. In your post tag us with @paintshopcanada AND using the hashtag #paintshopproject.

Unlimited entries per person. All entries become the property of Paint Shop and will not be acknowledged or returned.

# **THE DRAW**

At the end of the contest period all valid entries will be included in a random draw. One winner will be drawn and announced on Paint Shops' Facebook and Instagram pages, and will be contacted via Facebook Messenger or Instagram Direct on or before April 1, 2022.

#### THE WINNER

The winner must be able to pick-up the prize at their nearest Paint Shop location. By entering the Contest, the winner agrees to take sole responsibility for the pick-up of the prize and ANY costs or damages they may incur as a result. The Winner agrees to forfeit the prize if they do not pick up the prize thirty (30) days after initial contact has been made to them by Paint Shop.
